Strategic Objectives

As the global economy is to head out of the pandemic crisis, the Euroasian region is set to become one of the economic and strategic cornerstones for future strategic developments that can provide multiple opportunities to political and business stakeholders. In partnership with the Association "Conoscere Eurasia" and Russian Union of Industrialists and Entrepreneurs (RSPP), Luiss School of Government and Confindustria's Sistemi Formativi (SFC) have joined forces in delivering a unique advanced executive course aimed at keeping policy makers and managers abreast of current developments in the Euroasian region and associated business and strategic opportunities.

Through a combination of advanced online/in presence classes led by leading national and international academics and business experts, this executive course aims at:

- Providing a comprehensive overview of current political and strategic developments in the Euroasian region;
- I Mapping how these developments are affecting international relations within the region;
- Identifying areas of current and future business cooperation and development;
- Creating an advanced network of professionals interested in exploiting the political and economic opportunities arising from the region in the short and medium term.

At the end of the course, participants will:

- I Gain the skills for impactful, effective economic and strategic impact of the Euroasian region;
- Learn from a mix of top educators, researchers and practitioners representing national organisations and private sector companies operating in the region;
- Share experiences and build a lasting network with peers from the region.

Academic Partnerships

Luiss School of Government

Set within Confindustria, who reunites more than 150,000 Italian companies of all sizes, employing over 5 million people in Italy, SFC maintains a strong local presence and a network organisation for providing training and funded programmes sector at the national and international level. In particular, SFC's network facilitates the sharing of information, experiences and know how, promoting examples of excellence as well as major projects for business and the enterprise system.

Associazione "Conoscere Eurasia"

An independent, non-party and non-profit organization. Founded on 10th November 2007 as an expression of the Honorary Consulate of the Russian Federation in Verona, Conoscere Eurasia aims at developing economic, social and cultural relations between Italy, European Union, the Russian Federation and the Eurasian Economic Union. Conoscere Eurasia is interested in the development of its activity with the countries of Central Asia (Azerbaijan, Uzbekistan, Tajikistan), Russia has always played a propulsive role with such, and with the countries of the Shanghai Cooperation Organization, where China, India and Pakistan are effective members and Iran and Mongolia are observer members. The members of the Association are private citizens, companies and formal organizations, residents in Europe and Eurasia.

Program and Structure

This unique executive course is structured along thematic modules involving 75 hours of classes and meetings with leading academics and professionals from the Euroasian region. The effectiveness of the course is enhanced by its advanced teaching methodology involving a structured mix of:

- In-presence classes at the beginning and at the end of the course
- Intensive online classes distributed over a definite schedule allowing professionals to combine their active participation with professional engagements.

The course involves the following four thematic modules:

Euroasian Geopolitics: Historical Approaches

Participants will be provided with an overview of relations within Euroasia since the XIX° century with a focus on the

ambitions, self-perceptions and perceptions of others, power relations, imperial strategies and colonial mechanisms. Through its comparative perspective, this module will allow participants to gain a detailed insight of how current issues are heavily influenced by geopolitical experiences and traditions.

Euroasian Geopolitics Today

Building upon the historical approaches, participants will continue their advanced training by gaining a detailed overview of the current state of geopolitical interactions within the region and external partners. Particular attention will be directed to issues related to the perception of hegemony and associated security strategies.

Euroasian Geoeconomics

The historical and current assessment of Euroasian geopolitics provides the basis to comprehend the current intricacies connected to present-day economic and trade development in the area. At the end of module, participants will gain the necessary political and economic knowledge to identify the most relevant and effective commercial strategies taking into consideration the evolving social and technological developments in the region.

Learning from Experts

The expertise and knowledge gained in the three modules will be complemented with direct interactions with regional economic and political experts. They will be sharing direct experiences and successful cases of economic and commercial developments while describing specific strategies and best- practices required to be successful actors in the region.

Participants are expected to attend the opening and closing classes to held at Luiss Guido Carli in Rome and complete all classes to be delivered online using the university's Cisco Webex Platform.

Throughout the course, participants will be supported by a dedicated academic tutor and will be able to access relevant class material shared via the Moodle's enabled Luiss Learn platform.
